**Home Boarding Terms and Conditions  
(Pet staying at MY home)**

1. You have read and agree to TLC Pet Sittings terms and conditions. You agree with the booking form for each booking and will let TLC Pet Sitting know of any changes.
2. Hours of Boarding and Pet Creche start at 8.00 am. Creche pets must be collected before 6.00 pm. Overnight boarders are to be collected by 10.00 am the next day. If overnight boarders are not collected by 10.00 am on the last day, a day creche is charged. If later than 6.00 pm another night s charged.
3. Pets can only be booked in and out between the hours of 8.00 am until 10.00 am and 2.00 pm until 6.00 pm.
4. Only when the booking form is returned and the 50% deposit (non refundable) is paid, will it be regarded as a confirmed booking. I accept that no refund will be given if I return home earlier than arranged.
5. Pet food and soft bedding is to be supplied by the Pet Owner.
6. Animals are not left on their own for longer than 3 hours.
7. Dog walking is charged extra.
8. Collection and delivery of pets is charged as an additional fee.
9. Our cancellation policy for home boarding is as follows: 50% non refundable deposit. 8-13 days before booking 75% and 1-7 days before 100% fee is due. Our cancellation policy for Day creche is 48 hours or the full fee is due.
10. I understand that I leave my pet/s with TLC Pet Sitting entirely at my own risk.
11. We agree to contact you or your next of kin in an emergency. If not we reserve the right to act on your behalf and with a Vets advice at pet owners expense.
12. Clients must declare to TLC Pet Sitting any aggressive tendencies their dog may have or any destructive behaviour problems before the contract is signed and that their dog had not at any time prior to date attacked any human/dog. Any damage to TLC Property due to destructive behaviour will be paid for upon return by the dog owner.
13. In the event that your dog bites another human/dog, becomes aggressive or is uncontrollable by TLC Pet Sitting we hold the right to re-home your dog for the duration of its stay.
14. I understand that in case of death a post mortem may be needed and disposal of the body will be cremation. This s at the pet owners cost.
15. I would/would not like the ashes to be returned and agree to pay the additional fee for this service.
